1. Call to order; establish quorum;
2. Individual members of the public may address the board for a maximum of three minutes on items not on the current agenda, for a collective total of fifteen minutes.

Members of the public will speak on agenda items after comments are called for by the presiding officer, but before Board discussion and consideration of the item. Individuals of the public may address the board for a maximum of three minutes per person per agenda item, for a collective amount of fifteen minutes per agenda item;

4. Discuss and consider action on minutes of the March 8, 2023, regular meeting;

6. Review and approve the quarterly investment report for the 1st quarter FY2022-2023; (C. Sisk)
7. Receive monthly report from Chief Smith with SMHCEMS regarding emergency operations, response times, call volume, training, management activities, and membership;
8. Discuss and consider action on National EMS staff appreciation week gift bags for SMHCEMS during the week of May 21 – 27, 2023; (Baker, Sisk, Hervol, Jarden)
9. Discuss and consider action on changing monthly board meeting dates;
10. Discuss time, place, date, and agenda items for next meeting; and
